



## MOTORHOME PARKING TERMS & CONDITIONS

These Motorhome Parking Terms & Conditions are supplemental to the Booking Terms & Conditions you accepted when booking your package.

### 1. DEFINITIONS

- 1.1. In these Motorhome Parking Terms & Conditions, the following words and phrases shall have the following meanings:

**Confirmation:** the letter or email we send to the Lead Booker accepting and confirming a Motorhome Parking Request.

**Contract:** these Motorhome Parking Terms & Conditions, the Motorhome Parking Request and the Confirmation.

**Designated Parking Area:** the area of land where the Motorhome Parking is situated.

**Documentation:** documentation and/or accreditation in relation to the Designated Parking Area and the Motorhome Parking.

**Group:** each person who ultimately receives the benefit of the Motorhome Parking and/or is a passenger in the Motorhome.

**Lead Booker:** the lead booker who has purchased a Motorhome package.

**Land Owner:** the ultimate owner or entity/person that controls the Designated Parking Area.

**Motorhome:** the vehicle provided to you as part of your package.

**Motorhome Parking:** a parking space for a Motorhome including any additional confirmed Parking Services.

**Motorhome Parking Request:** a request by the Lead Booker to offer to purchase Motorhome Parking via the relevant page on the Lions Rugby Travel website.

**Parking Services:** services available in addition to the parking space as set out in the Confirmation.

**Total Cost:** the total cost of the Motorhome Parking Request as set out on our invoice.

- 1.2. Capitalised terms not defined in these Motorhome Parking Terms & Conditions shall have the meaning as set out in the Booking Terms.

### 2. APPLICATION OF THE MOTORHOME PARKING TERMS & CONDITIONS

These Motorhome Parking Terms & Conditions are supplemental to the Booking Terms accepted by the Lead Booker when booking their package and shall apply to the Motorhome Parking. All other Booking Terms shall continue to apply to the Lead Booker's package and these Motorhome Parking Terms & Conditions do not affect the Lead Booker's booking or other package conditions that do not relate to Motorhome Parking. The Lead Booker is entering into a separate Contract to purchase the Motorhome Parking. The Motorhome Parking does not form part of the Lead Booker's package.

### 3. HOW TO REQUEST MOTORHOME PARKING

- 3.1. The Lead Booker may request Motorhome Parking by completing the online Motorhome Parking Request process.
- 3.2. Each Motorhome Parking Request submitted by the Lead Booker shall be deemed to be an offer by the Lead Booker to buy the Motorhome Parking. The Lead Booker shall ensure that the Motorhome Parking Request is complete and accurate.
- 3.3. All Motorhome Parking is subject to availability and we shall not be bound to provide the Motorhome Parking unless and until we issue a Confirmation to the Lead Booker.
- 3.4. Once a Confirmation has been issued to the Lead Booker, the Motorhome Parking cannot be cancelled.
- 3.5. Please note, we may require further information from you to issue a Confirmation relating to your Motorhome Parking Request. We will contact you to request this information if required. We will not be liable for any delay in you accessing the Designated Parking Area if we have not received the information within the timescales requested or the information you have provided us with is incomplete or inaccurate. We reserve the right to issue you with an administration charge of £25 if this occurs.

### 4. MOTORHOME PARKING

- 4.1. The Lead Booker acknowledges that the Motorhome Parking is supplied subject to the Land Owner's Terms & Conditions and other reasonable directions or instructions it may make from time to time to which you agree. The Land Owner's Terms & Conditions may be amended from time to time. The Lead Booker will ensure that its Group are aware of and comply with the Land Owner's Terms & Conditions.
- 4.2. It is important that your Group comply with all signs in the Designated Parking Area. If you do not comply with the signs and instructions, you may be removed from the Designated Parking Area and your right to park and use the Parking Services may be withdrawn. You may be asked to move your Motorhome within the Designated Parking Area.
- 4.3. You must not park within an area that is designated for a specific purpose when you are not entitled to do so. For example, and without limitation, parking in an area designated for disabled persons without an appropriate disability badge, or parking in an area that has not been assigned to you in your Confirmation.
- 4.4. We will supply the Motorhome Parking to the Lead Booker as set out in the Confirmation but shall not be responsible if the Motorhome Parking is unavailable for reasons outside of our control. In which case we will refund the Motorhome Parking Total Cost but no compensation will be payable.
- 4.5. Parking locations at the Designated Parking Area are allocated from our official allocation. You acknowledge that you may be required to park where instructed and/or parking allocations will be on a first come first serve basis over which we have no control. You may not necessarily be parked together with other Lions Rugby Travel customers or parked in the same location throughout the duration of your booking.

- 4.6. Where available, maps showing the Designated Parking Area and/or locations of Parking Services are for information purposes only and are made available as a guide. The guides are not to scale, but are an approximation. The Land Owner reserves the right to alter, move or reallocate Motorhome Parking and locations at its sole discretion. We may not be informed of such re-organisations or re-categorisations.
- 4.7. You accept that transportation to and from the Designated Parking Area is not included in the booking and is at you and your Group's own cost.
- 4.8. We are not responsible for the Parking Services and/or any additional services or products purchased and/or used by you or your Group at the Designated Parking Area. You acknowledge that whilst these Parking Services and/or services may be made available to you, they are not included and do not form part of your booking.
- 4.9. You understand and acknowledge that the Land Owner or its representatives reserves the right to refuse a Group or Motorhome entry to a Designated Parking Area or to remove a Group from a Designated Parking Area if the Land Owner or its representatives deems their behaviour to be inappropriate, in breach of the Land Owner's Terms and Conditions or that they are likely to behave in a manner contrary to public order and safety. The Land Owner's or its representative's decision is final.
- 4.10. The Lead Booker will be responsible for all damage caused to the Designated Parking Area and/or Parking Services by its Group.
- 4.11. The Motorhome Parking is provided entirely at your own risk. Please ensure that your Motorhome is left securely locked and all valuables out of view. We will not be responsible for any loss or damage caused to the Motorhome from use of the Motorhome Parking. We cannot guarantee the security of your Motorhome and/or its contents.
- 4.12. You accept and agree that other members of the public may also park within the Designated Parking Area and/or use the Parking Services over which we have no control. The Designated Parking Area is not exclusively for the use of Lions Rugby Travel.
- 4.13. There may be CCTV security cameras within the location of the Designated Parking Area. However, you acknowledge that the presence of the CCTV security cameras do not make any representation or guarantee of the coverage provided in regards to the security of your Motorhome.

### 5. MOTORHOME PARKING DOCUMENTATION DELIVERY

- 5.1. We will distribute your Motorhome Parking Documentation to you in a manner that we deem most appropriate. We will inform you of which method of distribution we intend to use prior to departure but reserve the right to amend this at any time. Once distributed, the Motorhome Parking Documentation is your responsibility and cannot be replaced.
- 5.2. You will not be provided with the Motorhome Parking Documentation unless all invoices issued by us to the Lead Booker have been paid in full.
- 5.3. The Lead Booker shall be responsible for inspecting the Confirmation and Documentation on delivery to ensure that the Confirmation and Documentation is accurate and complete. Once received by the Lead Booker the Motorhome Parking Documentation is at the Lead Booker's risk and the Lead Booker shall be fully responsible for the safety and security of the Motorhome Parking Documentation and the onward delivery of such documentation to its Group.
- 5.4. We will be under no duty to replace or reimburse the Lead Booker or its Group for any Motorhome Parking Documentation that is lost, damaged, destroyed, defaced or stolen and shall not be liable to the Lead Booker or the Group in respect of the same.

### 6. PAYMENT

- 6.1. The Lead Booker shall pay the Total Cost within 14 days of the date of the Confirmation. No Motorhome Parking Documentation shall be provided until payment of the Total Cost has been received by us in full and cleared funds.
- 6.2. Payment by American Express Charge and Credit Card, Visa Credit or MasterCard payment, is subject to the card provider's service charge of 1.5%.
- 6.3. If you fail to make payment in full on the due date, without prejudice to any other right or remedy available to us, we may cancel the Motorhome Parking and resell the Motorhome Parking to a third party without liability to you.

### 7. CANCELLATION OF YOUR PACKAGE

Once confirmed, the Motorhome Parking is non-refundable as it is a separate contract. Should you wish to cancel the Motorhome Parking you will not receive a refund of the Total Cost.

### 8. OUR LIABILITY TO YOU

Nothing in these conditions excludes or limits our liability for death or personal injury caused by our negligence or fraud or fraudulent misrepresentation. Our total liability in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise, arising in connection with the Motorhome Parking shall be limited to the Total Cost and as otherwise set out in the Booking Terms.

### 9. MISCELLANEOUS

- 9.1. We shall not be liable to you for any breach of our obligations under these terms and conditions if such breach is due to an act, event, omission or accident beyond our reasonable control.
- 9.2. These conditions are not intended to benefit, or be enforceable by, anyone else except the Land Owner.
- 9.3. These Motorhome Parking Terms & Conditions are governed by English law and the jurisdiction of the English Courts.
